By signing this form I understand that:

- the performance of investment markets is unpredictable, and that I may receive a negative return from time to time
- for any change to be effective, my form must be completed and received by 5 pm (EST) on the last business day of the week I understand that any switch made to my existing account will be processed using the unit price determined on the close of business Friday (of the week in which the switch request was received). I understand that if I change my future contributions investment strategy any amounts coming into my account will go into my new option(s) from the week after my switch request is received
- the Trustee's administrator will not action my request if the information is incomplete or ambiguous
- the first switch I make to my existing account balance in any financial year will be free and I will be charged a switch fee for each additional switch made. There is no charge for changes made to my future contributions investment strategy
- the onus is on me to ensure the Fund's receipt of my *Investment switching form*
- in the event that I have selected a combination of investment options, the initial percentage allocated to each investment option will move over time due to factors such as market movements and it is my responsibility to monitor and rebalance the percentages in each option over time
- the information on this form will be handled by the Trustee to process my investment option choice
- to process my investment option choice, the Trustee may disclose my personal information to the administrator or any other party necessary and I consent to the handling of my personal information in this way
- to access my personal information I can contact the Fund's Privacy Officer.
