## Announcing NGS Super Scholarship Award winners: Management category



The inaugural NGS Super Scholarship Awards have been extremely successful with over 100 applications received for 2010. The variety and scope of applications impressed the judges, along with applicants' evident passion, enthusiasm and dedication to the education sector.

Although submissions in the Management category set a high standard, the judges found two stood out. While the proposed projects differed considerably, the applicants' desire to improve and contribute to non-government education was equally strong.

**Shane Gubbin**, Head of Curriculum at St Pauls College, SA received the first Scholarship Award in the Management category. In his application, Shane outlined the development of a program to enhance and generate industry participation and involvement in Vocational Education and Training (VET) at a newly constructed Trade Training Centre organised by a number of Catholic schools. In addition, a major objective is to establish a clear understanding of the training programs being delivered by the centre.

On receiving his award, Shane said, "I was surprised and delighted to be chosen as the winner of the Scholarship Awards for 2010. This project is one which I have been eager to implement since construction of the Grand Junction Trade Training Centre started in May 2010."

The second award in the Management category was presented to **James Fenoughty**, Principal/CEO of the Marcellin Technical College, SA. James aspires to establish a project to assist young indigenous students to become self-sufficient in their education and training through a partnership with the Ltyentye Apurte School, which is located south east of Alice Springs.

James affirmed, "There is a need for young indigenous students to complete their education and hopefully embark on a career pathway through a school-based apprenticeship programme."
