

NGS Super investment performance summary to 30 June 2013 (Pension)

Returns on pension investments are tax-free. Pension investment returns will exceed equivalent (taxed) superannuation investment returns in periods when investment earnings are positive. In periods when investment earnings are negative, superannuation returns will exceed equivalent pension returns. A negative return (loss) means that less tax is payable on taxed superannuation investments than has already been accrued, so there is a tax adjustment that can be credited back to superannuation members. There is no equivalent adjustment for pension members because pension returns are tax free.
