TERMS AND CONDITIONS OF ENTRY

- 1. Applications must be received by 11.59pm on Wednesday 31 August 2022.
- 2. NGS Super Scholarship Awards are provided by NGS Super Pty Limited ABN 46 003 491 487 AFSL 233 154 (NGS Super).
- 3. NGS Super *Scholarship Awards* are open to all NGS Super members. Applicants **must be** active members of NGS Super and Australian residents. NSG Super directors, staff and their immediate families are not eligible to apply.
- 4. Applicants may apply for an NGS Super Scholarship only once in any calendar year.
- 5. All applications will be considered by a judging panel. The panel will examine the applications for the following:
 - contribution to and improvement of the education sector
 - the relevance, uniqueness or innovation of the applicant's proposal
 - the professional growth to be gained by the scholarship recipient and the capacity for this to benefit the broader educational sector.
- 6. Subject to Clause 8:
 - up to 18 finalists will be chosen from the applicants
 - 6 winners will be chosen from the finalists
 - one of these 6 winners will be selected as Judges' Choice.
- 7. Subject to Clause 8:
 - 6 scholarship grants of \$5000 will be disbursed by NGS Super for a project undertaken by each scholarship winner
 - finalists who are not awarded scholarships will each receive a \$100 gift card
 - scholarship winners who receive a grant are <u>required</u> to provide a written or video report on their outcomes, experiences and discoveries once their project has been completed. It is expected that the activity will be completed and any funds claimed before Wednesday 1 November 2023. The activity must be started after the application date and cannot be backdated to include previously completed or current expenses or courses.
- 8. The judging panel or NGS Super may, at its discretion and without prior notice:
 - vary any of these terms and conditions including without limitation any dates, the number of finalists chose and the number of scholarships awarded
 - require scholarship applicants to be interviewed
 - withdraw or vary a scholarship between the time that it has been awarded and the time that the final scholarship payment is scheduled to be made. Once awarded, a scholarship may be withdrawn or varied only where:
 - the scholarship winner's application was granted for a specific project or purpose for the particular school/employer nominated on the winner's application, and the winner has given notice to that school/employer of his/her intention to terminate employment, or
 - an event occurs that leads NGS Super to believe that it would be detrimental to its interests, or to the interests of a particular scholarship winner's employer or the education sector in general, for that winner's scholarship to continue.
- 9. **Finalists and scholarship winners will be notified by Monday 31 October 2022.** NGS Super may publish the name, state and employer of any finalist and may include references to and photos of the finalists on its website and social media platforms and in its communications.
